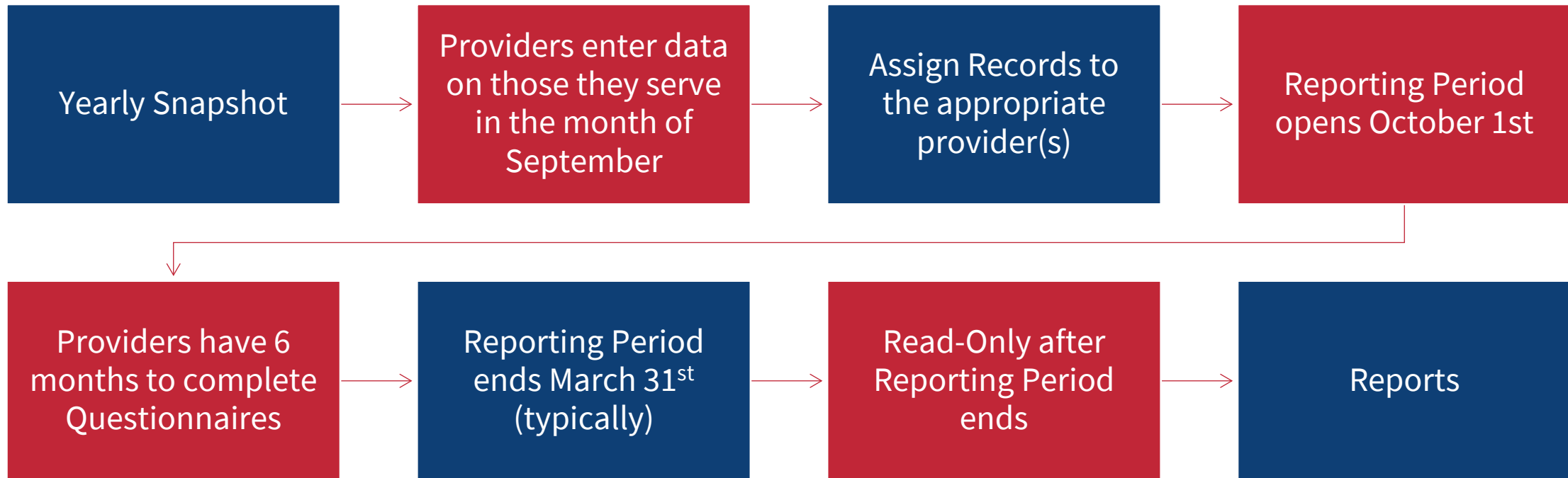

BACKGROUND/OVERVIEW

- OTS captures how people are spending their days
 - Does not focus on individual outcomes identified within a person's plan
 - Focuses on the larger systems outcomes that are happening with services
 - Allows DODD to align policies, procedures, and legislation that will improve how people live, work, and play in their communities

HOW DATA IS PULLED INTO OTS FOR PROVIDERS

Criteria 1:

- Billed (and claim is processed) for one of the following services in the last 12 months
- Services include:
 - Adult Day Supports
 - Ohio Department of Aging Supports
 - Vocational Habilitation
 - Group Employment Supports
 - Individual Employment Supports
 - Career Planning Services

HOW DATA IS PULLED INTO OTS FOR COUNTY BOARDS

Individuals are active in CRM-IDS

- No termination date
- No date of death
- Enrollment or Re-Enrollment date entered

Billed for services (Criteria 1)

- If still in the business of providing services

Services marked in CRM-IDS (Criteria 2)

- Locally funded
- Competitive Employment
- Services include:
 - Adult Day Supports (Community or Facility)
 - Ohio Department of Aging (Community or Facility)
 - Vocational Habilitation (Community or Facility)
 - Group Employment Supports
 - Individual Employment Supports
 - Career Planning
 - Competitive Employment

HOW DATA IS PULLED INTO OTS FOR ICF/DC

Criteria 3

All individuals flagged as residing in the facility

- 18 years of age or older

Paid Supports

- IO Waiver
- Level One Waiver
- SELF Waiver
- ICF
- Local Funds
- Local Funds – Contracted with Ohio Department of Aging
- Other

Provider Services

- Adult Day Support
- Vocational Habilitation
- Individual Employment Supports
- Group Employment Supports
- Career Planning
- Career Planning – Worksite Accessibility
- Career Planning – Assistive Technology Assessment

Most recent Place on the Path to Community Employment

- PPCE is entered within CRM-IDS for County Boards
- PPCE is entered within the Portal for ICFs
- PPCE will also pull into the OhioISP

PLACE ON THE PATH TO COMMUNITY EMPLOYMENT (PPCE)

- Each person of working age in Ohio is required by the Employment First Rule to participate in a person-centered planning process
- During this process, people are required to identify their place on the path to community employment (PPCE)
- There are only 4 Places on the Path
- County Boards enter the PPCE in CRM-IDS in the Services/Supports Tab
- ICFs enter the PPCE in the Portal for each person
- PPCE will be pulled into OTS 15-days prior to the Reporting Period beginning

COUNTY BOARD CHECKLIST

- Are individuals “Active” within DODD systems? Or “terminated” if needed?
- Have you updated the person’s Place on the Path to Community Employment?
- Are the Services and Supports updated within CRM-IDS?
- Have you selected “Competitive Employment” within CRM-IDS, if applicable?
- Does a person have a submitted Acuity Assessment Instrument (AAI), if applicable?
- Does the person have an identified gender and DOB entered in the DODD system?

ICF/DC CHECKLIST

- Have you completed the Level of Care (LOC) process?
- Has the Individual Transfer Record (ITR) process occurred?
- Have you updated the person's Place on the Path to Community Employment?
- Does a person have a submitted Acuity Assessment Instrument (AAI), if applicable?
- Does the person have an identified gender and DOB entered in the DODD system?
