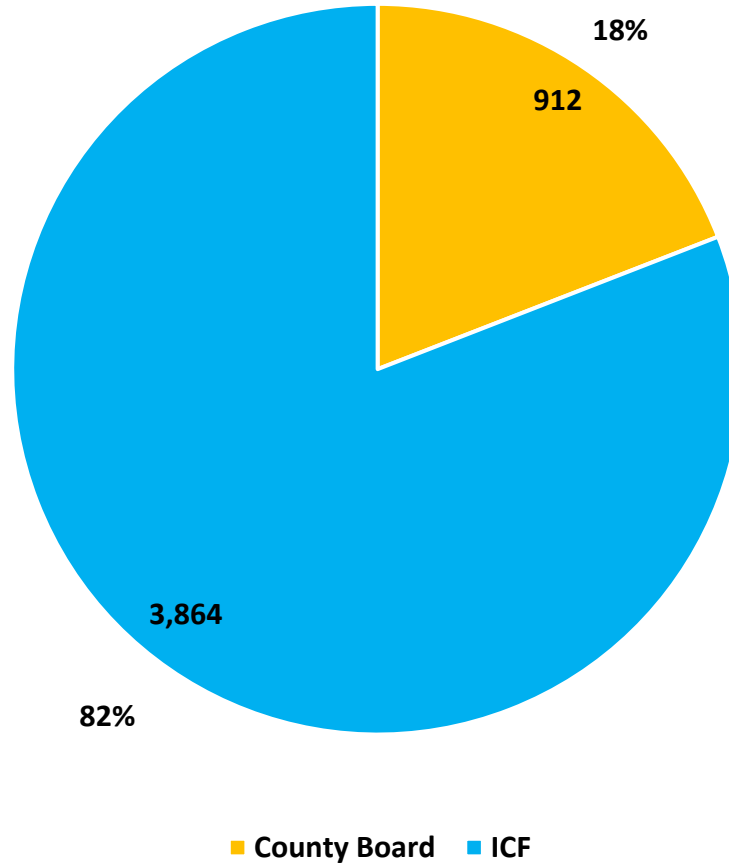

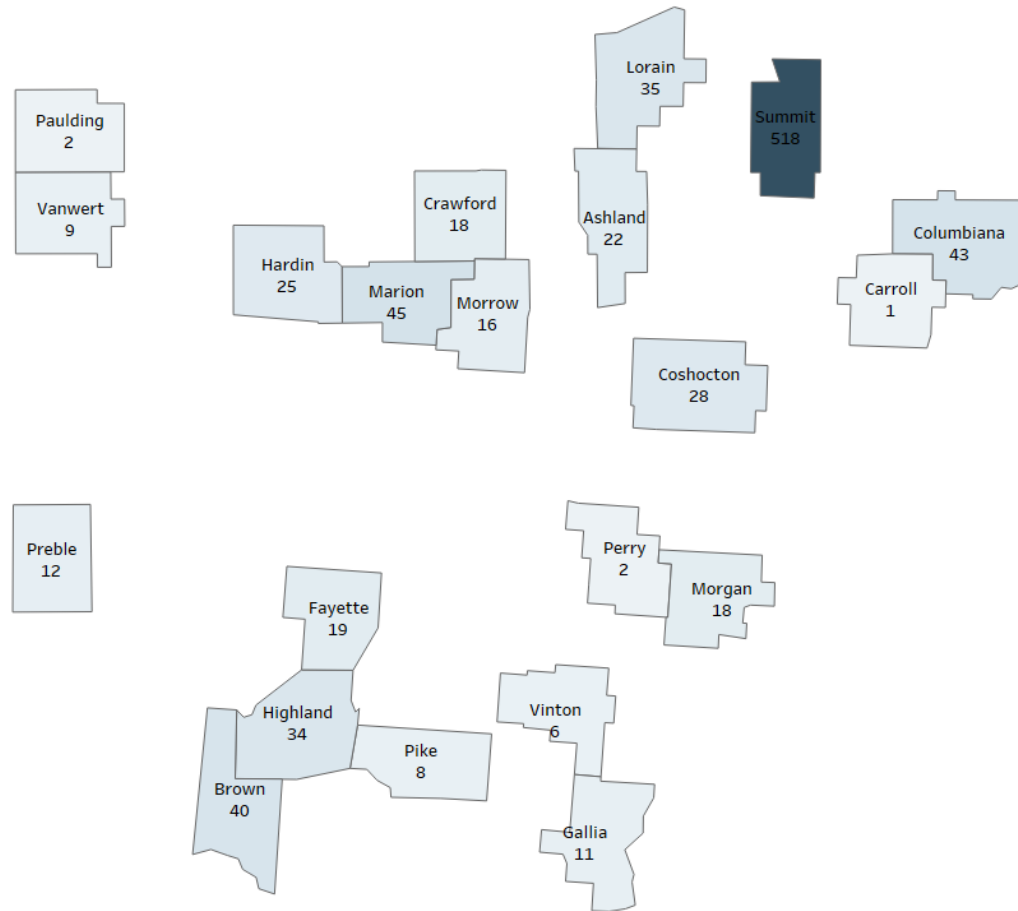

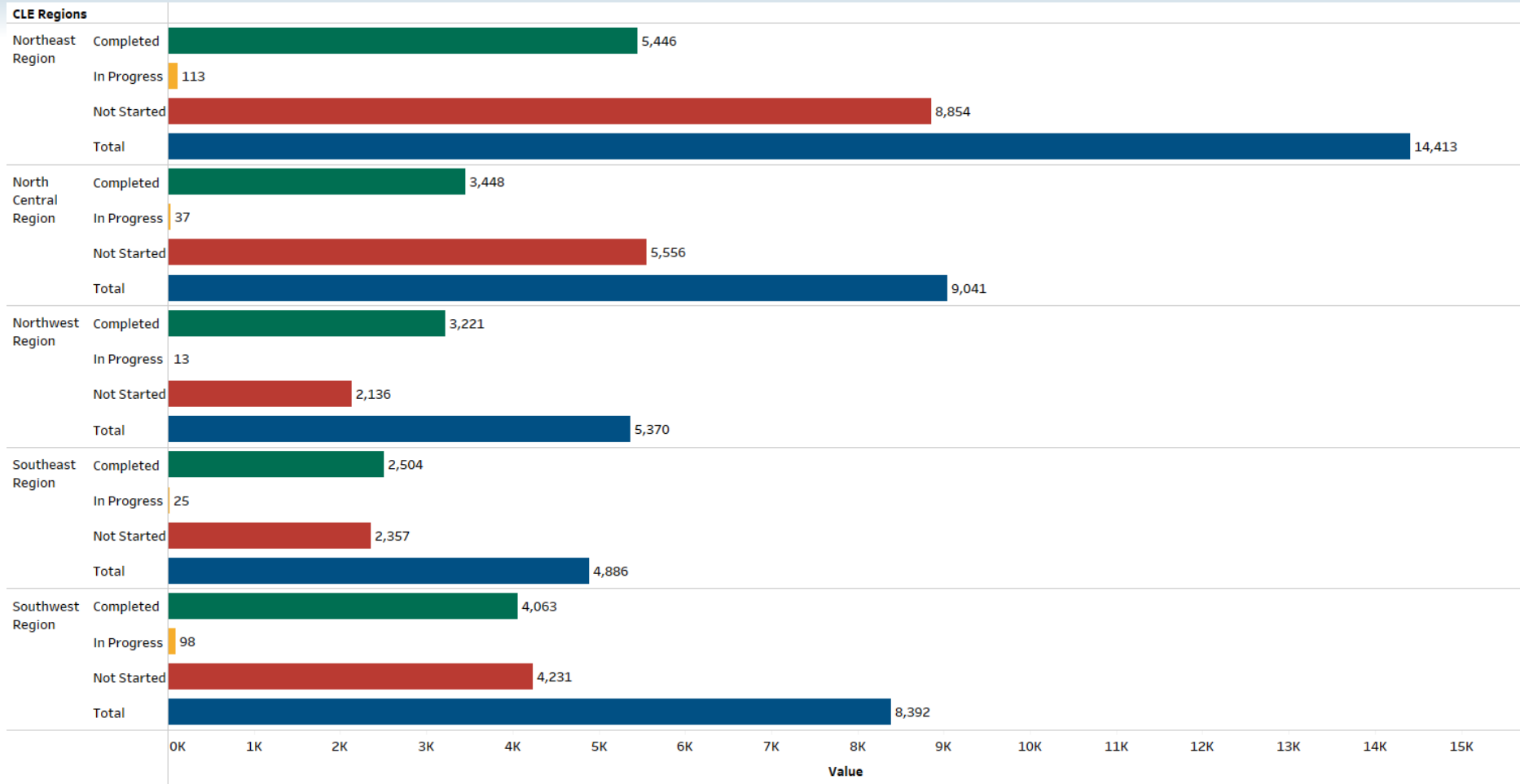

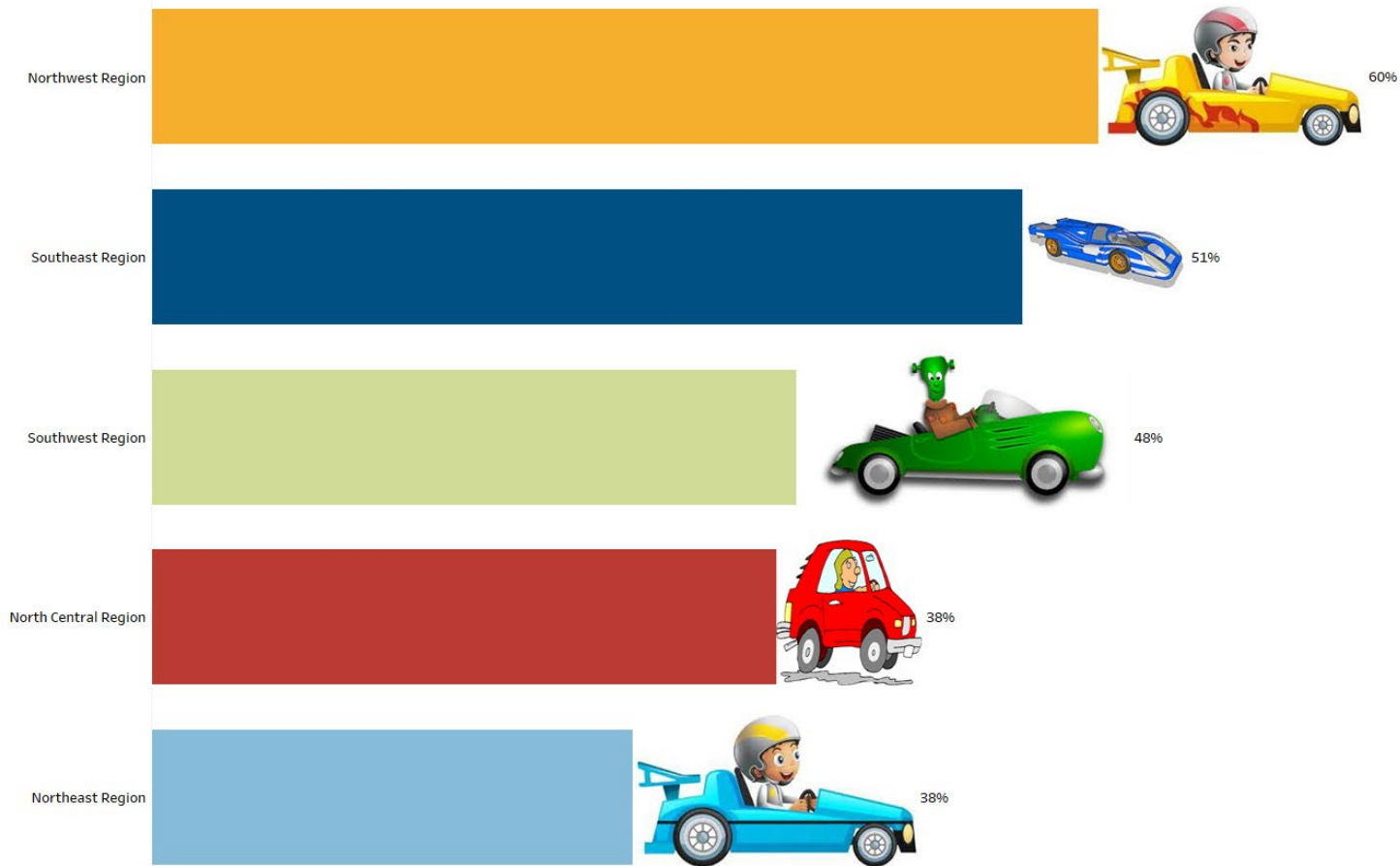


Regional Comparison
