## **Adult Day Support Quality Pilot**

The Blueprint for Adult Day and Employment Services proposal includes a new opportunity to create a pilot program for Adult Day Support (ADS) waiver services. The purpose of this pilot program is to see if investing in quality and offering incentives can help improve ADS waiver services and outcomes for people who need them, especially those with complex needs.

The ADS Quality Pilot Program will start in October 2023 and continue until June 2025. The program plans to invest about \$10.6 million each year in ADS waiver service providers. The Department of Developmental Disabilities (DODD) will review and approve applications from providers who want to join the pilot program. Participating providers will receive payments based on how much they improve their services and the outcomes they achieve for the individuals they support.



## **Adult Day Support Quality Pilot**

- Here are the important dates for the application process:
  - · The application will be available starting on September 25, 2023.
  - Providers can submit their applications from 2 PM on October 12, 2023, to 2 PM on October 16, 2023.
  - Selected providers will be notified by October 27, 2023.
  - The pilot program will begin on October 30, 2023.


